DEFERRAL OF 11 JUNE 2026 PUBLICATION CYCLE TO 09 JULY 2026 AIRAC

1. INTRODUCTION

1.1 A number of significant airspace and instrument procedure changes are scheduled to occur concurrently in mid-2026. To ensure all stakeholders have been provided with sufficient time to prepare, the AIRAC effective date will be adjusted from 11 June 2026 to 09 July 2026.

2. OVERVIEW

- 2.1 To ensure all stakeholders have been provided with sufficient time to prepare, the 11 June 2026 publication effective date will be adjusted to 09 July 2026 for the ERSA, DAP, DAH, AIP Charts and AIP book.
- 2.2 It is important to note that all planned publication cycle cut-off dates, as per the published document amendment calendar, will remain unchanged to ensure any residual impact to the 03 September 2026 and 26 November 2026 publications are minimised. Refer Appendix 1.
- 2.3 An extensive communication campaign is currently underway to advise data originating organisations and aerodrome operators.
