# NORTH QUEENSLAND EXERCISE PERIOD, QUEENSLAND 11 NOVEMBER - 11 DECEMBER 2024

#### 1. INTRODUCTION

- 1.1 Elements of the Royal Australian Air Force (RAAF) will conduct activities over the period 11 November 11 December 2024.
- 1.2 The exercise period supports graduation exercises for Australian Fast Jet operational conversion. The activities involve a wide range of tactical flying activities within permanent Townsville restricted airspace and Temporary Restricted Areas (TRA) to the west of Townsville. Aircraft will operate from RAAF Base Townsville.
- 1.3 This AIP SUP describes the airspace, timings, access and procedures associated with these activities.

#### 2. AIRSPACE

2.1 Airspace users should refer to Townsville Airspace (TLX) and Brisbane FIR (YBBB) NOTAM to confirm vertical limits and activation timings for permanent airspace and temporary restricted areas.

2.2 During the exercise period all, or some, of the following Townsville permanent restricted and danger areas will be activated with vertical limits and timings published by NOTAM:

2.4 Townsville airspace activation. Airspace volumes listed in paras 2.2 and 2.3 are planned to be activated in support of NQ Exercise Period for various periods daily (excluding weekends). TRA 'Porcupine' and TRA 'Copperfield' shall not be activated outside the following periods:

#### 2.5 Non-exercise airspace activation

- 2.5.1 Townsville permanent airspace may be activated for non-exercise activities in accordance with normal NOTAM requirements.
- 2.6 **NOTAM.** Townsville (TLX) and TRA (YBBB) NOTAM shall be issued to confirm activation timings and vertical limits. Timings may be amended or deactivated by NOTAM at short notice.
- 2.7 NOTAM will be issued at least 24 hours prior to activation.

#### 3. MILITARY AIRCRAFT OPERATIONS

- 3.1 Noise and sensitive areas
- 3.1.1 Military aircraft will plan to avoid known sensitive areas, and comply with Fly Neighbourly Advice.

#### 4. ACCESS TO EXERCISE AIRSPACE

- 4.1 Unless issued prior approval, access to restricted areas by non-participant aircraft is not available except for:
  - a) Aircraft operating in the preservation of life or property (MEDEVAC, FFR, POL, SAR)
  - b) Aircraft with a declared emergency
- 4.2 No ATS provided to civilian aircraft requiring emergency transit of the NQ Exercise Period Airspace.

5.1 This SUP self-cancels at 202412110800 UTC.


