RAAF BASE TINDAL (KTR/YPTN) RWY 14/32 UPGRADE PHASE 2 - RWY 14/32 EXTENSION

1. INTRODUCTION

- 1.1 This AIP SUP cancels and replaces SUP H145/24 on 28 OCT 2024 with Phase 2C works commencing.
- 1.2 This SUP is to provide notification to aircraft and ground operations in regard to the RWY 14/32 upgrade works by the Department of Defence during 28 October through 01 May 2025 Phase 2.
- 1.3 Airfield construction work as part of the EST00347 Project upgrades continues with the commission of extended main runway and taxiway. These construction works include excavation, pavement construction, NAVAID and Aerodrome Ground Lighting (AGL) changes/additions.
- 1.4 All works affecting aircraft operations, including preparation works, will be advised via the distribution of a Method of Working Plan.
- 1.5 The actual date and time of works will be advised by NOTAM.

2. WORK PROGRAMME

- 2.1 Phase 1 THR RWY 14 displacement (completed).
- 2.2 Phase 2 RWY 14/32 (main runway) extension open.

2.2.1 North western end RWY 14/32:

- DISP THR RWY 14 will be removed permanant for the entire period referenced under this SUP.
- b) RWY 14 HIAL is now in commission.
- RWY 14/32 DTRM have been adjusted in accordance with amended runway length.
- d) TWY names renamed to align with RWY extension (See Appendix 1).
- e) New Air Movements Apron is now in commission.
- f) Revised Type A chart N/A.
- g) Approaches remain surveyed to former RWY14 DTHR. NOTAM provide further details.
- h) Due to ongoing works, parts of TWY A will be closed until May 2025. Refer Appendix 1.
- i) RWY 32 THR is relocated, as such TWY availability changes as of 28 of October. Refer Appendix 2 for availabilities.
- j) Aircraft Arrestor Systems (AAS) positions detailed in Appendix 1. Southern AAS BAK12 permanently raised for departure end use.
- k) See Appendix 1 for lighting and navaid availability
- I) EMRWY 09/27 will become active and EMRWY 18/36 will be U/S.


