TOWNSVILLE/TOWNSVILLE INTL AERODROME (YBTL) RWY 01/19 AMENDMENT TO DECLARED DISTANCES

1. INTRODUCTION

- 1.1 This SUP provides operational information for users of Townsville/Townsville INTL Aerodrome (YBTL) regarding changes to declared distances for RWY 01/19 and Runway End Safety Area (RESA) as part of the Runway Extension project.
- 1.2 The existing RWY 01 Take off Distance Available (TODA) of 2,640M will be reduced to 2,498M as a result of the northern clearway being reduced from 202M to 60M.
- 1.3 The northern RESA dimension will also be republished as 240M x 90M commencing from the runway strip end which is in accordance with *Part 139* (Aerodromes), *MOS Section 6.26* as the minimum distance and width required for a Code 4 runway.
- 1.4 Approach survey data for RWY 01/19 will be available from Townsville Airport. Contact details as follows.
- 1.5 Pilots are reminded to check YBTL NOTAM information during works to ensure they are using the correct RWY distances.
